	<p>Mr. Boone provided his report to the Board.</p> <ul style="list-style-type: none"> • Mr. Boone circulated a draft of the school accreditation letter of intent for Board review. The Board suggested a few minor changes. Mr. Boone will make these changes and bring the final draft to the October Board meeting for final approval and signature. • Enrollment is currently 549 students, with one additional student joining the school in October. FSCS will have enrollment of 550 students by the end of October. • Mr. Boone asked the Board if it would be possible to extend the 25% reduced parish tuition rate, currently available to FSCS teachers, to employees who work in our parish offices. The Board discussed this request. <p>Motion: Tom Durand made the motion to extend the full time employee discount, offered to school employees, to the full time employees of the three sponsoring parishes.</p> <p>The motion was unanimously approved.</p> <p>Terese circulated a letter to parents regarding the 8th grade graduation Mass for Board review. <p>Shimshock Work Agreement Addendum</p>	<p>Motion: Tom Levandowski made the motion for FSCS to reimburse up to \$30.00 per month of Terese Shimshock’s smart phone data package.</p> <p>The motion was unanimously approved.</p>	<p>Tom Levandowski</p>
<p>Strategic Plan Objectives/Action Plans</p>	<p>The Board met on Wednesday, August 31st to discuss the FSCS Strategic Plan. Tom Levandowski introduced special guest Mimi Palen-Clare to discuss the plan objectives. Mimi circulated a draft of the FSCS Strategic Plan objectives and action plans for Board review.</p> <p>The Board provided comments on the objectives. The Board then discussed ways to measure progress on objective #7, “Improve student body engagement in formal worship and classroom prayer”. Tom Durand, Terese Shimshock, and Fr. Charlie will meet to further define how to measure objective #7. Tom Levandowski recommended removing objective #8, “Submit a BOD update/article for the Principal’s Newsletter after monthly Board meetings”, from the objectives and including it only in the action plans.</p> <p>Mimi forwarded a project plan template to the Board for possible future use. Mimi will add investigating the possibility of a parent advisory council to the list of objectives and action plans. Tom Levandowski suggested putting this item in the parent survey for the accreditation process.</p> <p>The Board assigned Board members to each objective and action in the Strategic Plan. The next step is to write out the detailed action plans for these objectives, including steps and timelines.</p> <p>After action plans are in place, the Board will be ready to complete the scorecards, describing how the objectives and action plans will be implemented. Septemberfest Update	<p>Susan Johnson provided an update to the Board on Septemberfest.</p> <p>As of this morning, 206 tickets have been sold. Susan circulated a list of volunteer needs. \$15,400 has been raised in sponsorships to-date. Sponsorships were budgeted at \$26,000. There are no further leads for sponsorships at this time. The scaled-back expenses for this event are \$30-35K.</p> <p>Sue Riesgraf and Andrea Douglas are working on marketing needs for the event. Fr. Tim Wozniak asked if H.S.A. checked with Catholic Mutual on whether or not the dunk tank is covered on the FSCS insurance policy. Mr. Boone will confirm this with H.S.A.</p>	Susan Johnson
